**UPDATED DATA: Care home testing for Covid-19  
- regular updates from T-DAB and Person Centred Software**

The latest data suggest that only 5% of care home residents were tested in the last 7 days. This is a decrease of 1% from the last period reported nearly week ago.

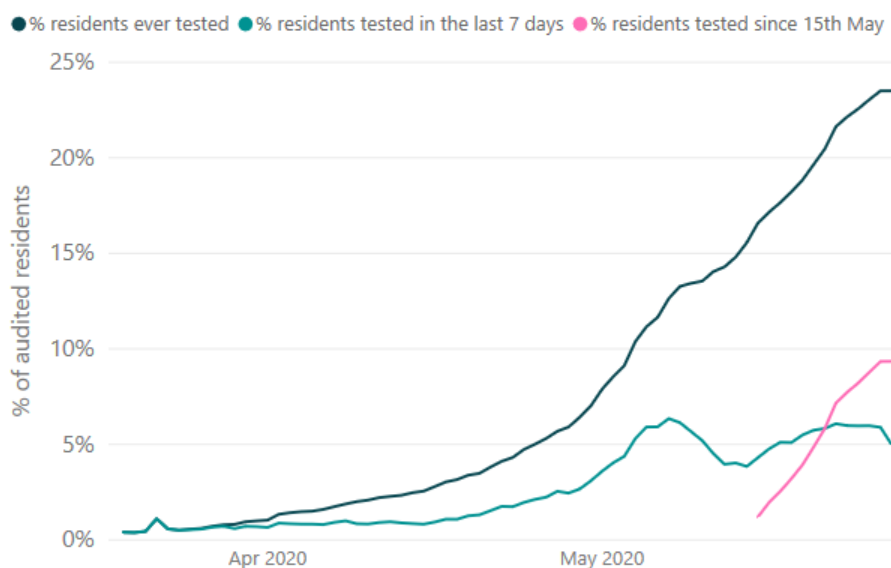
9% of residents have been tested since 15<sup>th</sup> May when the government pledged to Covid-19 test "every resident and every member of staff in our elderly care homes in England between now and early June"

In total, 23% of care home residents have received a test at any point

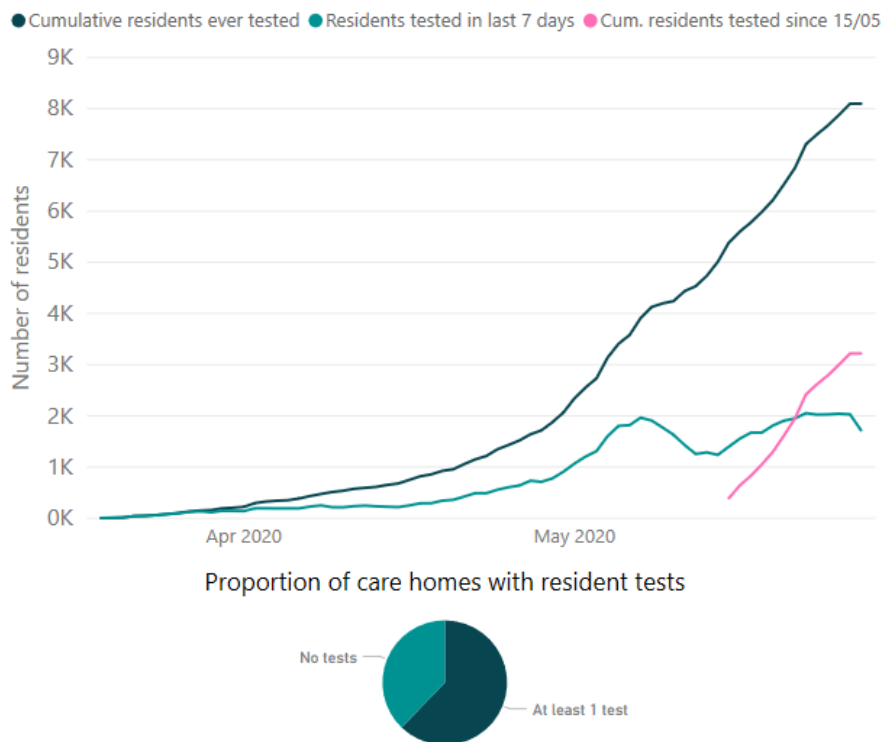
38% of care homes have had no residents tested since the epidemic started

*If quoting this data please note: This new research comes from The Data Analysis Bureau and is based on anonymised data from Person Centred Software, one of the leading suppliers of near real time management information systems to the care home sector.*

This analysis is conducted by The Data Analysis Bureau (T-DAB) based on anonymised data from Person Centred Software. It will be updated daily and expanded to include data on testing for carers in the residential setting. Simon Papworth, co-founder and director of Person Centred Software, said: “Our anonymised data covers thousands of care providers, including private and not-for-profit, from single home providers to large groups. This up to date insight of Covid-19 testing provides a close representation of the current situation in care homes across the country, providing a more representative picture than any individual adult social care provider could provide.”

Simon Briscoe, Director of T-DAB said: “It is worrying that we have no evidence of an increase in the rate of testing of care home residents in the last week as we approach the end of month target set by the government for every care receiver to be tested.”

Eric Topham, CEO of T-DAB said: “This analysis uniquely provides higher velocity reporting of Covid-19 status of individuals, at scale. The data provides a granular view of the state of suspected cases, testing, infection, and deaths in care homes. We will be releasing more in-depth, specific analyses to understand patterns in care practices, policy, and Covid-19 outcomes. The insights from the Person Centred Software data will allow government, home owners, carers, residents and their families to see the progress being made with Covid-19 testing in care homes.”

*Notes for Editors:*

*Data*

*The data above relates to the period from 18<sup>th</sup> March up to May 27<sup>th</sup> 2020. There is no equivalent up to date information on the sector as a whole because more than half of the homes have no detailed, timely or automated data collection.*

*The graph in this release shows the Covid-19 testing of care receivers as a percentage of the care receivers population for which a Person Centred Software Mobile Care Monitoring (MCM) Covid-19 audit was undertaken. The dataset represents a total sample size of 32,000 care receivers from 1,200 care homes across England, Wales and Scotland. This is a sub-sample of the total care homes in the MCM system. In order for a care receiver to be included within the observational group, they must have had a Covid-19 audit form filled out in the MCM software. This data covers a minority of care homes but as many as any other provider. Given the geographic spread and size of the Person Centred Software client base, there is no reason to believe that the sample is not broadly representative of the sector.*

- *'% residents ever tested' corresponds to the count of residents having been recorded as being tested<sup>1</sup> at least once since 18th March, as a proportion of all residents audited since 18th March.*
- *'% residents tested in the last 7 days' corresponds to the number of residents recorded as being tested<sup>1</sup> in the 7 preceding days as a proportion of all residents audited since 18th March.*

<sup>1</sup> *Residents identified as 'being tested' are those for which the status 'in test' or 'tested – confirmed' was recorded in their audit. The date at which either of these appears first, is taken as the date of testing. In the case where there is no record of 'in test', and 'tested – confirmed' appears first this date is used.*

The government announced on 11 May that “All symptomatic and asymptomatic care home staff and residents in England are now eligible for testing. Testing will be prioritised for care homes that look after the over 65s.”

Minister of State for Care Helen Whately said: “Care homes are on the frontline in the fight against COVID-19 and we are determined that staff have everything they need to keep themselves and their residents safe. Testing is a crucial part of this. It helps prevent and control outbreaks and means steps can be taken to reduce the spread the virus and protect the most vulnerable.” “Testing asymptomatic workers helps prevent and control outbreaks. It means those who test positive can be isolated, reducing the number of people who can spread the virus and protecting the most vulnerable. It also helps to build up a strategic understanding of the prevalence of the virus in local areas and the sector as a whole.”

On 15 May at the daily briefing Secretary of State for Health and Social Care Matt Hancock said: “We will test every resident and every member of staff in our elderly care homes in England between now and early June”.
